Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing company, pre-need plan issuer, general agent in pre-need plans and time shares/club shares/membership certificates issuers or selling agents thereof. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

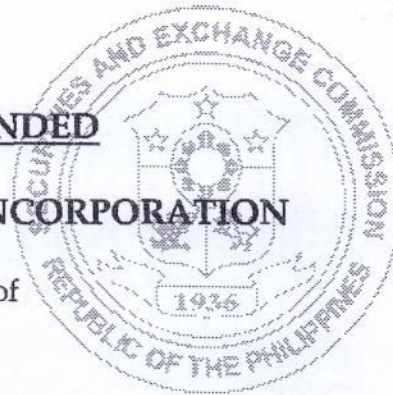

KNOW ALL MEN BY THESE PRESENTS:

That we, residents of the Philippines, have associated ourselves to form a Corporation under the laws of the Philippines and

- WE DO HEREBY CERTIFY -

FIRST. - That the name of this Corporation is and shall be "PHILIPPINES FIRST INSURANCE CO., INC."

SECOND. - That purposes for which this Corporation are formed are as follows:

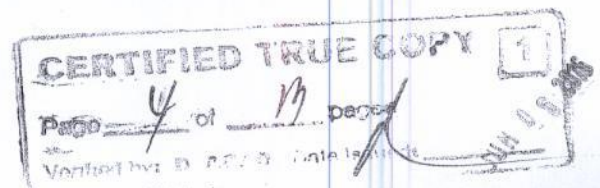
(a) To engage in the business and operation of all kinds of insurance, reinsurance, insurance on buildings, automobiles, cars and/or other motor vehicles, goods and merchandise, goods in transit, goods in storage, fire insurance, earthquakes insurance, against accidents, and all other forms of undertaking to indemnify any person against loss, damage or liability arising from unknown or contingent events, except life insurance.

(b) To issue marine insurance covering steamers or sail boats, goods and merchandise, and other things of value loaded in said steamers, sailboats, airplanes, trains, trucks and trailers and all other forms of conveyance by land, by water or by air.

(c) To grant loans out of its funds or deposits against mortgage on improved real properties which are not otherwise encumbered and which are located in the Philippines.

(d) To execute, sign and carry out all kinds of bonds and surety undertakings of every kind and nature guaranteeing jointly and severally, the performance of contracts, agreements, obligations and duties of all kinds: guaranteeing the fidelity of persons holding public or private offices or offices of trust, quedans or warehouse receipts, or any other form of contract.

(e) To accept agency on commission basis for bond, life, fire and marine insurance companies or for insurance against any risk of any kind of accidents; and

(f) To appoint such general agents, sub-agents or representatives locally or in foreign countries.

THIRD. - That the principal office of the Corporation shall be established or located 7th Floor, iACADEMY Building, 6764 Ayala Avenue, Makati City: the Board of Directors may establish and maintain such branch offices within or without the country as it may deem convenient or necessary for the business of the corporation. (as amended on May 6, 2005) *(As amended by the Board of Directors and Stockholders at separate meetings held on 28 June 2013 and 24 September 2013.)*

FOURTH. - That the term for which said Corporation is to exist is FIFTY (50) YEARS from and after the date of incorporation and extend for another FIFTY (50) YEARS from and after the expiration of its term on February 24, 2004. (as amended on January 9, 2004)

1. On 28 June 2013 and 24 September 2013, respectively, at separate meetings at the principal office of the Corporation, the Corporation's Board of Directors, by a majority vote of its members, and the stockholders, by affirmative vote of two-thirds (2/3) of the outstanding capital stock of the Corporation, approved the following amendments to the Corporation's Articles of Incorporation:
 - 1.1 Article III of the Articles of Incorporation by changing its principal office address from "Metro Manila, Philippines" to "7th Floor, iACADEMY Building, 6764 Ayala Avenue, Makati City"; and
 - 1.2 Article VII of the Articles of Incorporation to increase the Corporation's authorized capital stock from Two Hundred Fifty Million Pesos (Php250,000,000.00) divided into Two Million Five Hundred Thousand (2,500,000) shares to Ten Million (10,000,000) shares with an aggregate par value of One Billion Pesos (P1,000,000,000.00)
